Definitions

Service

Service is the <u>www.nemotravel</u>.com website operated by Nemo Travel Ltd.

Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

Usage Data

Usage Data is data collected automatically either generate by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

Cookies
